

Identify and Invest in Promising Approaches



- Economic model to identify promising approaches that control costs associated with Alzheimer's
- Initially use model to estimate savings and return on investment for in-person caregiver support
- Results reflected in Health Affairs and subsequent Net Savings analysis

Increase Detection and Improve Care



- Develop and disseminate Practice Tools that support providers in assessing, diagnosing, treating and managing dementia
- Develop dementia curriculum for health professionals and standards for health care homes

Informed by research regarding stages of community readiness and engagement

- Initiate mobilization
- Establish organizational structure
- Build capacity for action
- Plan for action
- Implement
- Refine
- Institutionalize

Four-Phase Community Toolkit



Convene key community leaders and members to form an Action Team.



Assess current strengths and gaps within the community.



Review findings to understand your community's needs and develop a plan to take action.



ACT Together to pursue priority goals to foster community readiness for dementia.

Approach

- Informal method to gauge community readiness, raise awareness, create linkages and spark momentum for change
- A conversation, not a study

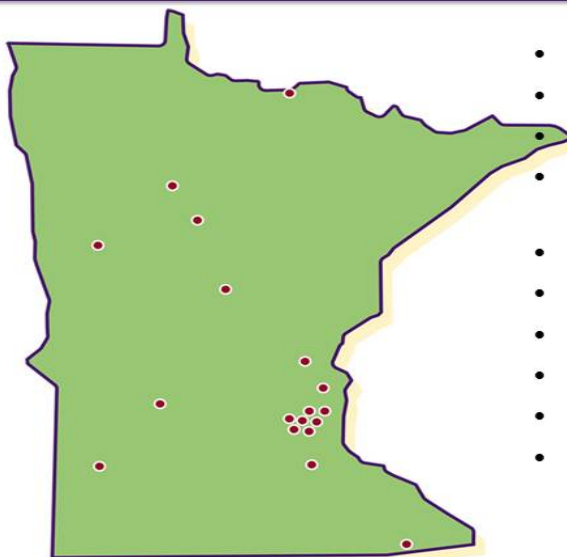
