- b. What are the clinical support tools that can be used to enhance communication between primary care and specialty care providers?

### C. Data Innovations to Promote Shared Decision-making Between Providers and Patients

**Question 3:** What are data-driven strategies for providers to effectively implement shared decision-making?

- a. How can innovative patient engagement techniques used by care delivery teams be integrated into digital health tools?
- b. How may AI impact the use of shared decision-making tools and increase patient engagement and empowerment?

### D. Measuring Improvements in Patient Engagement and Outcomes

**Question 4:** What are approaches to develop and implement measures of successful patient engagement and empowerment?

- a. What types of outcomes might be realized from successfully empowering patients?
- b. What types of research could be conducted to evaluate the effectiveness and outcomes of patient empowerment?
- c. What are optimal measures of successful patient engagement (e.g., patient access, efficacy, trust)?
- d. How can providers be encouraged to measure patient empowerment/engagement?
