- 2. What is the optimal mix of hospice and palliative care services for seriously ill patients, and how might this mix differ depending on the type, number, and degree of severity of their conditions/illnesses?
  - a. What are the most effective and innovative approaches for implementing and delivering hospice services for this patient population?

- b. What is the evidence related to the impact of providing concurrent hospice services on outcomes and patient experience?
- c. What are the challenges related to designing models that provide concurrent hospice services? What are some potential approaches for addressing these challenges?

# C. Patient Perspectives Regarding Palliative Care and End-of-Life Care

- 3. What are some evidence-based approaches for informing patients about their palliative care and end-of-life care options?
  - a. How can providers best work with patients and caregivers to assist in determining when palliative and/or hospice care is appropriate?
  - b. What are some approaches and performance measures that can assist in addressing equity issues regarding access to and use of palliative care and hospice care?
- D. Addressing Workforce Challenges Related to Caring for Patients with Complex Chronic Conditions or Serious Illnesses Through Clinical Leadership
  - 4. What are some approaches that can be used to address challenges the workforce (e.g., physicians, nurses, hospitals, social workers, community workers) may face when caring for this patient population?
    - a. What can be done to prepare nurses and other parts of the healthcare workforce to provide the care that is needed by seriously ill patients and their caregivers?
