Goals of the Summit

- Access
- Diversity and disparities, including gender, race, ethnicity, culture, language, literacy, sexual orientation, socioeconomic status, geographic location, and living situation (alone or with a caregiver)
- Etiologies and Disease Stages
- Care Settings, including home, community, assisted living, nursing home, and health care settings
- · Employment, training, and workforce
- Technology

Heterogeneity of persons with dementia, caregivers, and caregiving situations

- · One size clearly does not fit all
- How can we effectively and efficiently match care, services, and supports to the diverse needs of persons with dementia and their family caregivers



What's not covered

- Detection and diagnosis
 For the summit, we include as "persons with dementia" individuals who have a dementia diagnosis and individuals who have cognitive and functional impairment consistent with dementia but no formal diagnosis
- In depth focus on ongoing medical management of the person's dementia and co-existing medical conditions
