Dear Ms. Price:

I am writing in response to your Information Quality Act Request for Correction ("Request") dated July 1, 2004 and filed under the National Institutes of Health "Guidelines for Ensuring the Quality of Information Disseminated to the Public"<sup>1</sup> on behalf of the Vinyl Chloride Health Committee (VCHC) of the American Chemistry Council. The VCHC requests that the entry for vinyl chloride contained in the 10<sup>th</sup> and previous editions of the Report on Carcinogens (RoC) be changed in the 11<sup>th</sup>, 12<sup>th</sup> and future editions based on concerns expressed in your letter. I have reviewed your request and appreciate you bringing these concerns to our attention.

As noted above, we read the Request as a complaint about the 10<sup>th</sup> RoC, and have considered your comments. We believe that the issues you have raised will be addressed in the 11<sup>th</sup> RoC.

At the time we received your Request, the NTP was already in the process of preparing a revision of the summary profile for the 11<sup>th</sup> RoC based on the current, publicly available scientific literature. Based on this review, including the publicly identified literature identified in the Request, the NTP believes that strong evidence supports an association between vinyl chloride exposure and the appearance of angiosarcoma of the liver in humans. We believe that the evidence for an association of vinyl chloride with brain cancer is somewhat weaker than that for angiosarcoma. Further, newer studies suggest that lung cancer, lymphoma, and leukemia may not be associated with vinyl chloride exposure. We will send you a copy of the revised summary profile for vinyl chloride upon final approval of the 11<sup>th</sup> RoC by the Secretary.

I would like to let you know that you may appeal the agency's decision either in writing or electronically within 30 days of receiving this response. Because we will be revising the vinyl
