Mr. Collinge earned BA and JD degrees at the University of Arizona. He began his federal career in 1977 as a Vista Volunteer working for Southern Arizona Legal Aid in Tucson. Mr. Collinge joined the State Department in 1978 as a Foreign Service Officer and there met his wife who was in the same entering class. They married in 1981. He retired in 2009 from the Central Intelligence Agency. Post retirement Mr. Collinge worked until recently as a contractor and a consultant for the State Department and the CIA. Mr. Collinge has an avid interest in history, a love of Southern Arizona and enjoys baseball and travel. He volunteers for the Association for Diplomatic Studies and Training and at the River Road Unitarian Universalist Congregation in Bethesda, Maryland. He is active as a Family Advocate at Arden Courts, Kensington where Zandra resides and at IONA Senior Services at Tenleytown, Washington, D.C. where Zandra was the Wellness and Arts Program prior to entering long-term care.

Tim Engelhardt directs the CMS Medicare-Medicaid Coordination Office, dedicated to improving services for individuals dually eligible for Medicaid and Medicare. Prior to joining CMS in 2010, Mr. Engelhardt was a consultant with The Lewin Group, and he previously served as the Deputy Director for Long Term Care Financing at the Maryland Department of Health and Mental Hygiene. ## **Mary Hogan -- Family Advocate**

Mary Hogan's personal and professional lives were shaped by the arrival of her youngest brother Bill who was born with Down syndrome in 1960. She spent nearly 40 years as a Special Educator and since Bill's death in 2010 of complications of Alzheimer's disease, she has worked closely with the National Task Group on Intellectual Disabilities and Dementia Practices (NTG). Their shared focus has been to raise awareness of the increased incidence of Alzheimer's disease in the intellectual disability (ID) community, advocate for inclusion in the National Plan and address the challenges faced by individuals, families and care providers. For the past two years Ms. Hogan has co-facilitated an online monthly support group for families living with ID and dementia. She was a contributing author to the NDSS publication on *Aging and Down Syndrome: A Health and Wellbeing Guidebook* and to the most recent *Alzheimer's Disease and Down Syndrome, A Practical Guidebook for Caregivers*. She has also co-authored several articles related to the challenges of living and dying with ID and dementia and has presented on Down syndrome and Alzheimer's disease in a variety of forums. A long time attendee of the NAPA Advisory Council meetings, she remains dedicated to improving quality of life and quality care for this very special population.

## **Helen Kales, MD -- University of Michigan, Ann Arbor**

Helen Kales is Professor of Psychiatry at the University of Michigan (UM) and a Research Investigator in the Center for Clinical Management Research (CCMR) and the Geriatric Research Education and Clinical Center (GRECC) in the VA Ann Arbor Health System. She is also the founding Director of the UM Program for Positive Aging (PPA), a multifaceted UM program established in 2009. The PPA promotes team science via national and international collaborations in order to improve outcomes for older patients with dementia or mental health issues and their families. Dr. Kales served as Director of the Section of Geriatric Psychiatry from 2009-2014, overseeing all clinical, educational, and research operations, and building the Section to include ten geriatric psychiatrists, one of the largest academic concentrations of this specialty in the world. As a fellowship-trained, board-certified geriatric psychiatrist, her research program is directly informed by her clinical work and experiences with patients, families, providers, and systems to diminish the barriers to effective and high quality care for older patients with dementia or with mental health issues. Dr. Kales was named to the Lancet Global Commission on Dementia Care in 2015, and is recognized as an international expert in the behavioral and psychological symptoms of dementia, depression in later life and in pharmacoepidemiological research related to the prevalence and risks of use of antipsychotic and other psychotropic medications in patients with dementia.

### **Ellen McCreedy, PhD -- Brown University**

Ellen McCreedy is interested in improving the quality of remaining life for people with dementia. Her research goals are to reduce the amount of futile and burdensome care received at the end of life; and to provide comfort, meaning, and moments of joy to people living with dementia and their families. Professor McCreedy received her MPH in Global Health from the University of South Florida, her PhD in Health Services Research from the University of Minnesota, and recently completed a postdoctoral research fellowship at Brown University, Center for Gerontology and Healthcare Research. Dr. McCreedy is directing a pragmatic trial of a personalized music intervention to reduce agitation and isolation in nursing home residents with dementia.

### **Marisa Scala-Foley -- National Association of Area Agencies on Aging, Aging and Disability Business Institute**

Marisa Scala-Foley is the Director of the Aging and Disability Business Institute at the National Association of Area Agencies on Aging (n4a), which provides community-based organizations with the tools and resources to successfully adapt to a changing health care environment, enhance their organizational capacity and capitalize on emerging opportunities to diversify funding. Recently, she served as Director of the Office of Integrated Care Innovations in the Center for Integrated Programs at the HHS Administration for Community Living, where she managed the agency's efforts to build the capacity of state and community-based organizations for delivery system reform. Before that she helped found and lead the Center for Benefits Access at the National Council on Aging. Ms. Scala-Foley has worked her entire career in the field of aging on issues related to health-care and long-term services and supports. She holds a Masters in Gerontological Studies from Miami University (Ohio), and a Bachelor's degree in Sociology/Gerontology from the College of the Holy Cross in Worcester, Massachusetts.
